Healing to Advocacy Program: 33 member-leaders were accepted into Essies Facilitators Training Program and attended three weekend-long retreats to prepare to lead cohorts. We then launched 12 new cohorts in ten cities: Los Angeles, Oakland, Vallejo, Rancho Cucamonga, Walnut Creek, Fairfield, Fresno, Sacramento, San Jose, and Stockton. Essie provided childcare to approximately 50 children in these cohorts as a form of barrier-reduction for participants. In Fall 2019, we held three joyful and standing-room-only graduation ceremonies across California for the 109 graduates of the Healing to Advocacy cohorts: one in the Bay Area (76 graduates), one in the Central Valley (10 graduates), and one in Los Angeles (23 graduates). This increased our total membership to 209 women with incarcerated loved ones. In the Spring, we held an overnight Love, Leadership, and Liberation retreat for member leaders.
